RE: U.S. and Mexican Catholic organizations call for immediate, complete end to Migrant Protection Protocols and fair access to asylum for all

President Biden and President López Obrador,

We are deeply troubled by the U.S. and Mexican governments reimplementation of the Migrant Protection Protocols (MPP). The undersigned U.S. and Mexican Catholic organizations working in immigration law, policy, and services urge you to work together to end MPP and the misuse of Title 42 to ensure fair access to asylum for all those seeking protection from violence and persecution.

It is shocking that the U.S has decided to move forward with reimplementation of MPP and expand it to countries such as Haiti. The consequences this policy has on the safety, dignity, and rights of asylum-seekers arriving at the U.S.-Mexico border are immense and devastating. In his message on the 107th World Day of Migrants and Refugees, Pope Francis calls on us as Catholics to move towards an "ever wider we." An accessible, welcoming, and just asylum system is necessary for the United States to respond to this sacred call to action.

We call on the U.S. to end this deadly policy as quickly as possible and to put forth a plan for accountability, including any and all steps necessary to ensure that MPP, or anything like it, never happens again. Like the previous U.S. administration's family separation policy, MPP caused horrifying and permanent harm to people in deeply vulnerable situations. While the damage can never be undone, we must take immediate and concrete steps now to recognize the dignity and humanity of asylum seekers in both words and action.

In addition to MPP, Catholic organizations in the U.S. and Mexico again call on the U.S. to end Title 42. The recently-announced decision to <u>lift travel restrictions</u> to the United States for vaccinated individuals further emphasizes the lack of validation for this policy. Instead of turning asylum-seekers away, and perhaps sending them to their death, the U.S. should offer COVID-19 vaccines for those who have been unable to access them in countries of origin and allow their asylum cases to proceed. We hope the Mexican government will join us in this call on the Biden administration.

The Holy Father <u>recently spoke</u> about the need to "work together through solidarity and subsidiarity in order to build a better society and emerge better from the Covid-19 pandemic." He says to us all: "You have the ability and the courage to create hope where there appears to be only...exclusion...With your hands, you know how to forge the dignity of each person, of families and of society."

President Biden and President López Obrador, we hold you in prayer and call on you to create hope by removing the barriers to asylum in your respective countries, including the Migrant Protection Protocols. As Catholic organizations working on the frontlines at our shared border, we stand ready, with outstretched arms, to welcome asylum seekers.
